Ross Watson, Scottsdale – 1 October 2020

At the 21 September2020 Council Meeting Mr John Marik Director — Corporate Services provided at Agenda Item 144/20, Waste Management Strategy Final Report, that there had been a direct improvement of \$218,045 when 2019/20 waste financials are compared to 2017/2018.

What is the total and individual breakdown of the amounts included in the waste financials for the 2017/18, 2018/19 and 2019/20 years?

Response from Director – Corporate Services, John Marik:

The total and individual breakdown of the amounts included in the waste financials for the 2017/18, 2018/19 and 2019/20 years are commercial-in-confidence and subject to confidentiality agreements. Divulging these figures jeopardises these commercial arrangements.

Mary Schramm, Ringarooma

Where the undergrowth in Bridport has been cleared last year, I've noticed an extensive growth of weeds. Does the Council have any plan to rehabilitate this area with native species?

Response from Mayor Greg Howard:

We do have some blackwoods planted down there, but the rest will just be maintained with sprays to keep the exotic species away.

Further Response from General Manager, Tim Watson:

In addition to that, the problem Council have when we have done some plantings, people have come and stolen them, which is pretty frustrating.

What about native grass? People don't steal that.

Response from Mayor Greg Howard:

The problem with planting grass is you have to mow it and it also becomes a fire hazard in summertime. The answer to that would probably be no.

On behalf of the people who live on Forsyth Hill Road and those in the areas of West Maurice Road, beyond where the tar seal is. There is very considerable traffic on this road. They request that Council considers sealing the road between East Maurice Road and Cottons Bridge Road and from the end of the sealed road to Cottons Bridge Road and up Forsyth Hill Road.

Response from Mayor Greg Howard:

I can tell you now that those two roads in particular would have a very low level of traffic compared to many of the roads in the municipality, which are equally not sealed. The cost of sealing roads these days is just exorbitant. You take the parameters for a sealed road versus parameters of a gravel road, and the speed limit from 80 km up to 100 km, just the design alone needs to change. It's basically out of our reach and we have something like 670 km of unsealed road in the municipality. Roads like the Old Waterhouse Road and Oakdene Road would have much more traffic than either of those roads, and we don't intend sealing any of those. We will continue to re sheet, grade and maintain it. The chances of having it sealed are almost zero.

Linda Borrell, Talawa

In regards to the speed limit through the town of Ringarooma it's currently 60 km and most built up areas are 50 km in towns. Are there any plans to have the speed limit changed in the Main Street of Ringarooma?

Response from Mayor Greg Howard:

No, the speed limit for most towns which have a major freight road and thoroughfare including Ringarooma, Winnaleah and Branxholm, those sort of towns basically are a 60 km zone. We would have to apply to the Transport Commission and have very, very good reasons why that needs to happen. I'd say it's highly unlikely.

Councillor Leonie Stein:

Are we still waiting on approval from Parks to clean up the debris left from the storm several weeks ago opposite the corner of Elizabeth / Main Street, Bridport? There have been a lot of complaints directed to Council staff in regards to this not being cleaned up. To those that I have spoken to I've suggested they contact Parks with their concerns. Do you know what the status is of that approval?

Response from Mayor Greg Howard:

When Council cleaned up after the storm, Council did it without a works permit to try and clean it up and get it out of the way and Parks put a stop work notice on us. We applied for a works order on 7 September, and followed it up on 7 October, and here we are 19 October and still haven't heard word. All they really need to do is a signature on a piece of paper. That just shows their incompetence.

I have also had a lot of queries from campers and people just in general that walk through the Caravan Park expressing their concerns regarding the danger of large trees that are precariously hanging over camp sites. These trees in question are very shallow rooted and my concern is with how damp the soil is currently and we've also been told of the La Nina forecast, of which wetter and windier conditions are expected. My question is, can we get an arborist to look at that and remove any dangerous trees before the holiday influx arrives?

Response from Mayor Greg Howard:

We do an arborist report for all the trees in our reserves and around the roads each year. We normally just act on that arborist report. We have done one for the caravan park but once again a works order to take out the dead wood of any dangerous trees was lodged the same day as the previous works order (mentioned above) on 7 September, and followed up on 7 October, and still haven't heard anything. They would probably give us a works order to remove the dead wood out of the tops of them, and maybe some pruning but in terms of removal, I wouldn't hold your breath.

Councillor Mervyn Chilcott:

Is there an update on the situation on the Sideling Road upgrade?

Response from Mayor Greg Howard:

Tim Watson, Dwaine Griffin and I have a meeting with State Growth on 28 October to bring us up to speed on the latest proposal which includes the Sideling and the route down Corkery's Road. The last time they were here they said it was too steep. We had a meeting and went over and took some new readings of where we thought the road should go, as opposed to where they wanted the road to go. Clearly where we want to go it's not too steep, they had to go away and re cost it and come up with a new design. We are hoping they will present that to us at this meeting.

Can we have an update on the rail trail at Scottsdale?

Response from Mayor Greg Howard:

Yes, we are close to having a development application ready for the Scottsdale end of the rail trail. Once that is lodged, we have to wait on the Minister to decide if we as a Council get to determine the development application (DA) or if he wants another Council to assess the DA. Once that's completed, Officers will then focus on finishing the DA for the City of Launceston municipality portion ready for submission.

Can we have an update on the Derby Depot?

Response from Mayor Greg Howard:

Nothing to add.

Have we received a reply back from the Government?

Response from Mayor Greg Howard:

No.

Councillor Edwina Powell:

Now that we have been made responsible for the rail corridor, to what extent can we guarantee that we can preserve the rails and sleepers, so that there can be the potential into the future for rail and track riding. My understanding is that the Legislative Council were wanting to encourage that the tracks and sleepers be preserved. Can we consider that?

Response from Mayor Greg Howard:

No they are not going to be preserved, it would mean that you would need to build the trail beside the current railway line. The current cost of \$40,000 -\$50,000 a kilometre to pull up the line, crush the ballast and form a trail, would probably blow out to between \$400,000 and \$500,000 a kilometre. It would blow the whole program out the water. The funding agreement we have with the Federal Government was always based on the premise that the rails and sleepers would be removed. The Legislative Council only said in their report that we 'should' maintain the rail sleepers where practical, and it's not practical from a cost point of view.
